

Recently, the ARC Committee has received a number of requests to remove trees as per the NINE Steps to Follow in Removing and Replacing Trees that was on the Baytree website (baytreeca.org). Unfortunately, the information contained within the NINE Steps was no longer valid as the County requirements for hardwood trees had changed. So, the Committee developed a NEW document to help property owners deal with removing trees (primarily hardwoods) called Easy Guide to Tree Removal and Replacement 11-2023.

We believe it is a simpler guide to follow when you need to remove a tree. It has been loaded onto the BCA website (www.baytreeca.org) and can be found by clicking on Architectural Review and scrolling down to the Easy Guide to Tree Removal and Replacement document and clicking on that document.

HOW DOES THE VIOLATION PROCESS WORK?

VIOLATION NOTICE

Got a letter from Fairway Management a while back. Said I had weeds in my landscape beds. It had been raining quite a bit, so I ignored it since it all looked fine to me. About 3 or 4 weeks later I got the same sort of letter again. It said I would be getting fined if I didn't get rid of the weeds in 14 days. I really didn't see anything too bad, so I ignored the letter again. I mean, those weeds would be

gone in a flash when it got hotter toward summer. I guess I thought this had all self-corrected, and I basically forgot all about it.

Well, about 3 weeks later I got a Certified letter. I've never received a Certified letter before. I thought it was some kind of marketing trick so I didn't want to sign for it. The mail carrier assured me this was probably important, so when I opened it up I was dumbfounded to see that I was being fined \$25 dollars per day until I cleared the violation!

The lucky part about this was that the letter scheduled me for a Due Process Committee hearing in 14 days to plead my case. I immediately called Fairway Management to find out what all this meant. The hearing would take place whether I attended or not. The fine would begin immediately unless the Committee decided otherwise. Well, to say the least, I got rid of my weeds ASAP, and the fining did not start.

I often wonder what would have happened if I had ignored that Certified Letter, or never gave Fairway a call. Well, I found out later that I could have been fined a maximum of \$2,000!! Safe to say that I won't be ignoring communications from Fairway or our Homeowners Association in the future. Everyone was very accommodating and would have given me all the time I need to correct the violation if I had extenuating circumstances.

Please Don't Feed Wildlife!!

You may have the best intentions, but feeding wildlife is illegal and dangerous for both you and the animals.

Human foods are **not healthy** for wild animals. Animals that eat our food may stop eating the nutrients they need to survive. They can stop hunting, foraging, or

scavenging as they would naturally.



Depending on humans for food is called food conditioning. **Food Conditioning** is dangerous for animals because it can lead to serious consequences like getting sick, starving, or even having to be killed if they become too aggressive. Animals can lose their fear of people when they get used to eating our food. Because they approach you people might think the animals are tame like our pets at home, but they are still wild creatures. If the animal feels threatened for any reason, it could bite, kick, charge, or attack you.

Let them stick to their natural diet. Feeding wildlife isn't safe for the animals or for you.
