Helpful Reminder for our new to Baytree Residents!



Hurricane Preparedness Kit Recommendations Provided by State of Florida.

To assemble your kit, store items in airtight plastic bags and put your entire disaster supplies kit in one or two easy-to-carry containers such as plastic bins or a duffel bag.

A basic emergency supply kit could include the following recommended items:

- Non-perishable food (enough to last at least 3 days)
- Water (enough to last at least 3 days)
- First-aid kit (include any prescription medication you may need)
- Personal hygiene items and sanitation items
- Flashlights (have extra batteries on hand)

- Battery operated radio (again, have extra batteries)
- Waterproof container with cash and important documents
- Manual can opener
- Lighter or matches
- Books, magazines, games for recreation
- Special needs items: pet supplies and baby supplies if applicable
- Cooler and ice packs
- A plan for evacuation and for if family members are separated

During a watch, prepare your home and evacuation plan in case a warning is issued. During a warning, carefully follow the directions of officials, and immediately leave the area if they advise it.

In the event of an Extreme Wind Warning/Advisory, which means that extreme sustained winds of 115 mph or greater are expected to begin within an hour, immediately take shelter in the interior portion of a well-built structure.

ARC Update – Rick Brown WELCOME TO HURRICANE SEASON

As we enter the 'height' of Hurricane Season the ARC Committee would like to make you aware of some courtesies that community residents have participated in over the past number of years. Namely:

- Keep gutters free of landscaping or yard waste. Place such waste in the area between the sidewalk and the gutter. This allows the free flow of rainwater to the drains.

- Those residents whose property is directly in front of storm water drains have tried to keep them clear of debris during the height of the Hurricane Season. This prevents drain water from backing up in the drain and, thereby, flooding the street. The CDD cleans those drains every year just prior to Hurricane

Season to make sure they are functioning properly.

Homeowners also need to aware that there are very specific covenants relative to the timing and use of Hurricane shutters. See Article 13; Section 13.21.11 Hurricane and Storm Protection of the Covenants.

TREE TRIMMING

Please be aware that Excessive tree trimming is a violation of the BPARCS (4.6.7.6). This is defined as pruning more than 25% of the tree's canopy and other activities (i.e., trunk girdling, excessive root cutting, use of tree-killing chemicals, etc.) which result in the effective destruction of a tree. Recently there have been some 'questionable' trimming activities. You should also be aware that Brevard County Ordinance 94-49 requires ALL lawn and tree contractors to remove yard trash generated from their operations.

Homeowners who have trees on their property that overhangs the sidewalk shall make sure the limbs do not impede bikers or walkers. Homeowners who have trees overhanging the street need to make sure that they are pruned to a height of 12 feet off the road. This includes trees located between the sidewalk and the street. Although the tree is a CDD tree the homeowner is required to maintain it (i.e. prune it). If the tree needs to be removed, the CDD is responsible to remove it, not the homeowner.

As the Chair of the Baytree CDD, I want to welcome all new and current residents to our great community. The Baytree Community Development District (CDD) manages and maintains all the common area property in the

community. This includes roads, ponds, common area landscaping, security, conservation and wetland areas and recreational facilities. The Baytree CDD assessment will show up on your property tax bill and will be \$2,000.00 per home for the upcoming year. For all information about the CDD, you can review our website at www.BaytreeCDD.Org. On that site you can find our budgets, meeting schedule, minutes and a lot of other information about the CDD.

For any residents interested in getting transponders, you can contact the District Managers Office at 407-841-5524, and they will schedule you for the next available appointment. The transponders are \$25/each, and to get one you will need to show your vehicle registration as well.

The CDD board would like for ALL residents to please obey the 25 MPH speed limit in our community. The only exception to this is on Kingswood Way and that is 20 MPH. The board has also noticed that not everyone is obeying the posted stop signs and continue on. Should you get caught by the Sheriff it is a whopping \$169.00 FINE. The board has instructed the deputies to issue tickets to those offenders. We have also installed additional speed humps in order to slow down speeders. They would not be necessary if everyone complied to the Law of 25 MPH. We are getting a lot of new residents that have young children and we certainly do not want anyone to hurt a resident or child by speeding. If additional speed humps are needed to slow you down the board certainly will consider that action. Just a reminder DO NOT PASS A MOVING VEHICLE on any roadway within the community.

As for my area of oversight, I am responsible for the landscaping. We have made several improvements to the front entrance over the last year, as well as improving the neighborhood monuments. Next year, we will be focused on improving the rear gate area.

Let's Go Walking...

Cooler weather means more outdoor activities and what is better than taking a walk. Besides the well documented health and fitness benefits of walking, it is also one of the few activities that only requires a good pair of shoes and the desire to get out and enjoy a breath of fresh air.

Walking through the gorgeous Baytree neighborhoods is always pleasurable yet exploring new territory can add some incentive to stepping out. Within a short drive of the community there are several new areas to explore.

Brevard County Zoo linear trail is probably the best-known walking trail in the area. Parking is available at the end of Murrell Road from which a board walk enters into a shaded natural area for approximately one mile. The trail extends another two miles with partial morning shade and several bridges over swampy areas.

Woodside Park, located at the corner of Murrell Road and Crane Creek Boulevard, has a pleasant nature trail, beginning at the future dog park. Winding for ½ mile through a palm and oak forest, this shaded walkway provides a peaceful setting for a leisurely stroll. As the walkway comes out of the woods, it proceeds another ½ mile along a lake, home to several mottled ducks and wading birds. At the end there is a choice to continue through a neighborhood back to Murrell Road or to reverse along the same path back to your car.

Wickham Park has a series of trails for walking. These are generally along sandy roads and paths through a variety of natural environments. Personal choice determines the length of the walk. This area is also used by off-road bikers so be prepared to share your walk.

Helen and Allan Cruickshank Sanctuary, located at 360 Barnes Blvd. in Rockledge has a trail through the scrub forest that is known for its very friendly scrub jays. The paths are often narrow and always sandy. The main path is less than a mile but

there are other paths to add distance. Shade is limited so go early in the day. The birds make this a great place to walk. (Please do not feed them)

A Uniquely Brevard Beach Find

Anybody who has taken a stroll on a Brevard County beach has surely noticed the plentiful ghost crabs digging tunnels in the sand just beyond the high tide line. I'm sure you have also noticed the ubiquitous chunks of coquina rock mixed in with the shells along the shore.

Something you may not know is that 100,000 years ago ghost crabs' bodies mixed with coquina rock to form petrified crabs...also called stone crabs. Scientists have studied these fossils and postulate that there is something unique about Brevard's coast and the exact type of coquina to allow for this fossilization process. Although ghost crabs are common in many areas, petrified crabs are only found between Melbourne Beach and Satellite Beach.
