COMMENTS FROM THE BCA PRESIDENT

In this the first of many periodic briefings to you fellow Members, I extend my very best greetings!

For those of you whom I have not had the pleasure of meeting, it is appropriate to provide a sketch of my background. I graduated from Mount St. Mary's University, Emmitsburg, MD, in 1960. I was commissioned in the United States Marine Corps for nearly 34 years of active service, attaining the rank of major general. Following retirement from the Corps, I was the President/CEO of a large trade association in the electroniccommerce industry. Sybil, my lovely bride for 50 years now, and I retired to Baytree 13 years ago. We have four adult children and three grandchildren. My education includes a BS degree (Economics); assorted professional military schools and management courses; and I graduated from the Naval War College (graduate-level education) with distinction in National Strategy and Policy. Mount St. Mary's University awarded me an honorary doctor degree (LHD) in 2005, for distinguished service to the Nation. Civic involvements include such positions as an association director in Fairfax, VA, for two terms; as a member of a Department of Defense Dependants School Board in Beaufort. SC: as a member of the St. John The Evangelist Catholic Community's Building Committee; and in several BCA elected positions. I am currently a Member of the Board of Trustees at Mount St. Mary's University, where I serve on both the Academic Affairs Committee and the Student Affairs Committee. Now. let's transition to BCA Matters.

Your Neighborhood Voting Member has informed you of the results of the Annual Meeting of the Voting Members and their selection of myself. David Taylor, and Donna Smail to serve as BCA Directors, each for a two-year term. At the Organization Meeting of the "new" Board, Dan Kaminski and Brent Mitchell were each appointed to a one-year, term. Once duly constituted, the Directors, unanimously gave direction to Marie Thibodeaux, BCA Manager, to inform Clayton & McCulloh, our contracted law firm, to cease work on the Declaratory Judgment sought by the

previous Board, in order to provide us, the current Directors, an opportunity to review the matter, including the Association's financial commitment to same. Per our By-Laws, as President, I scheduled a Special Meeting of the Board of Directors for the evening of 27 April. Your Neighborhood Voting Member has also provided you the results of that special board meeting. In essence, the Directors, voted unanimously (Dan Kaminski was absent) to cancel the Declaratory Judgment, and to seek return of the ten-thousand dollars "advance", which had been disbursed by the previous Board. Both results have since occurred!

Why did the Board do so? Of course, each Director arrived at his/her own assessment leading to their vote; and I share mine with you as follows. I focused exclusively on the chain of actions/inactions culminating in the pursuit of a judicial decision.

I focused not on the merits of any of the various voting-system proposals, all of which are blemished to varying degrees. I believe the substance of some proposals was not fully understood by all of the Voting Members when their votes were cast.

I question that all Voting Members were properly elected to vote in behalf of their respective neighborhood. I believe that the petition signed by some Voting/Alternate Voting Members did not present a grievance of sufficient magnitude to warrant the Declaratory-judgment initiative. In that regard, I offer that it is the Voting Members of the larger neighborhoods who are the more "burdened" in their representative responsibilities. I believe that during the proceedings, our Declaration, which was reviewed by Clayton & McCulloh and recorded with the Brevard County Clerk but a few months previously, was seriously violated in two instances. Article XVI precludes the Voting Members from amending the Declaration if affecting the powers of the Board of Directors or the Voting members. Further, Section 16.7, that Article, states in part, "No judicial or administrative proceeding shall be commenced or prosecuted by the BCA unless approved by a vote of the Voting Members representing seventy-five percent (75%) of the total votes in the BCA." The vote taken to seek a Declaratory Judgment was 86 votes insufficient (261 yes/201 no). Lastly, I believe our Governing Documents are sufficiently adequate to revise to any Owners' vast consensus. We should not depend on the expensive uncertainty of the judicial process.

In future endeavors of such importance, the Board of Directors, at the time, needs to ensure a more-patient approach to the study of all related courses of action and their potential impact on all entities of our Association. Such findings should be communicated to each Owner, permitting sufficient study and discussion

before a vote is sought. The catchyou-at-the-front-door approach and the "he said/she said" emails are harmful to the task.

In closing, I take seriously my twoyear commitment to serve you as an Association Director. I favor only the Governing Documents; a community of good will towards one another; and the enhancement of our property values. There is much work to do. and I shall provide you periodic updates.

PROPERTY INSPECTIONS

Management does inspections of homes every other month. We base our reports on the condition of your home and landscaping details.

We have been experiencing a lot more owners that are having their tree/brush clippings on the street several days before it's picked up. Please make sure your Landscaping Company removes their clippings.

Our policy is that it cannot be placed curbside until Sunday, for Monday's pick up. Our job is not to offend you if you receive a letter. We are only protecting the property values in Baytree and want your home/property to always look it's best.

Some of the areas that we look for are: cleaning of roofs, driveways and sidewalks, painting of homes, rust stains on homes/sidewalks, condition of yards-weeds, trimming, etc., Electrical boxes, gas meters, solar pipes, any type of piping/electrical on your home must be the same color of your home. A/C units and/or pool equipment must be screened in with mature shrubs so you are not able to see it from the street. We also need to note that shrubs need to be trimmed to less than 5 feet in height.

BCA ARC CORNER

Requests must be made in writing to the ARC if you plan to alter, modify or make improvements to your home. Such request includes items for landscaping, painting, pools, etc.

Absolutely NO FENCES or Arbors are allowed without the express written permission of the ARC. Please submit your request to: Attention Susan Bell, ARC Manager. You can drop them off to the guardhouse. Please feel free to download your application at our website: baytree-community.org

Invisible Fences - It's been brought to our attention that several owners have installed invisible fences for their animals. Please be advised that this is not allowed in Baytree. The County does not sanction these fences and pets still have to be leashed when outside your home.

We have had instances in the past where aggressive dogs have charged at other owners and these dogs have passed through the invisible fence. There have also been known instances where a mild manner dog that has been "enclosed" by this invisible fence" has been charged by an aggressive dog out on it's walk that has charged at the mild manner dog who can't get away since it's trapped by the fence.

We hope that this will give you some insight as to why Baytree nor the County endorses these invisible fences, because they do not work.

Oak Trees - Several owners have been cutting down oak trees due to disease, which must be approved by the ARC prior to cutting them down. The County has very strict guidelines on these trees as well as our documents. Those trees cut down must be replaced with the same size and type of tree.

MANAGER'S CORNER -FRIENDLY REMINDERS By Marie Thibodeaux, Manager

- Tree/Brush Clippings Clippings are not allowed to be placed curbside until Sunday due to Monday's pick up. Your landscaper should remove all clippings and take them to the dump. Please do not block storm drains when placing trash curbside.
- Trash Please put your household trash in garbage cans and not plastic trash bags. Our wild critters have a field day!

- Boats and/or Commercial Vehicles – Are not allowed unless you park them in a closed garage.
- Overnight Parking Parking in the streets overnight is prohibited.
- Blocking Sidewalks Please do not block the sidewalks when parking your vehicle for safety reasons.
- Dog Owners If you are out walking Fido, please don't forget to pick up after them. No one likes to step in a mess and the person behind the lawn mower would appreciate it also. We do have a problem with children walking dogs and not picking up after them.
- Speed Limit The speed limit is 25 M.P.H. within the community. Please slow down and be considerate of your neighbor.
- Garage Doors They must be kept closed when not in use.
